CAMP GAN ISRAEL OF THE ARTS COVID-19 GUIDELINES

In accordance with the recommendations of the CDC, and Department of Children and Families, Office of Child Care Regulation, and Palm Beach County Child Care Licensing, we have incorporated the following new guidelines and rules at our summer camp.

These rules may be updated and or changed as per CDC.

1. IMPLEMENTED SOCIAL DISTANCING

 \checkmark Only essential staff will be allowed in the building.

 \checkmark All our staff and any workers in the building have been screened according to the CDC guidelines and deemed safe to work in the school. All other people/ adults including parents will not be allowed to enter the building. (see drop off and pick up below)

✓ A daily rescreening of both children and staff will occur. (see screening details below)

 \checkmark 6 feet of social distance between children and their teachers will not be mandated during play.

 \checkmark Children will be comforted by an adult when needed.

 \checkmark Nap mats will be spread out during nap time.

2. INTENSIFIED CLEANING AND DISINFECTION

✓ We have been continuously cleaning and disinfecting the school while the kids have been out. We have disinfected every single toy, shelf, table, chair, cabinet, and utensil.

 \checkmark We will continue to implement a higher standard of sanitizing and increasing times for handwashing for both the children and teachers.

 \checkmark A nightly cleaning and disinfecting will also take place.

 \checkmark Toys will be rotated throughout the week to accommodate for a reasonable system of the daily sanitizing of toys.

 \checkmark Individual skill and sensory boxes like a "pencil case" will be made per child to limit the sharing of items such as pencils, markers, scissors etc.

 \checkmark Additional handwashing times for minimum of 20 seconds, has been updated and added to the class routine and schedule and has been posted in each room.

 \checkmark If your child remains for nap – the nap mat and all pillows and blankets will remain in school in large Ziplock bags (provided by you) and will be sent home Fridays for wash and return.

✓ Children cannot bring toys from home.

3. MODIFIED CAMP HOURS & APPROVAL FOR ENTRY

 \checkmark We will not be offering pre-care and after care.

✓ Camp will be from 9:00am-3:00pm.

 \checkmark We will be implementing a staggered drop off and pick up schedule to ensure a safe and organized drop off and pick up.

 \checkmark You must follow the designated times for your child and class.

 \checkmark All children will be screened before being allowed into class. (see screening procedures below)

4. CHILD SCREENING:

 \checkmark At any point, if any immediate family members contract COVID-19, the child will be required to stay home until the immediate family member is quarantined for fourteen days, and the child does not exhibit any symptoms for fourteen days.

 \checkmark If there is a confirmed case of COVID-19 in the school, either staff or children, there is a mandated 2-5-day closure (CDC guidelines) without reimbursement of tuition or fees. \checkmark Camp Gan Israel must be informed.

 \checkmark We ask that Grandparents or anyone with underlying medical conditions NOT be allowed to drop off or pick up your child as this is a risk to their health.

 \checkmark Please do your own screening at home before sending your child to school. Be sure they do not have fever, runny nose, cough, diarrhea, or any of the illnesses listed in our parent handbook, and do not medicate your child before sending to school.

 \checkmark You can help your child come out of the car and wait for the screening.

✓ You must be wearing a mask.

✓ You will need to wait while we screen your child. It will be done quick yet efficiently.

✓ We will take your child's temperature and check for any signs of illness.

✓ We will ask you basic questions about your child's and family's health.

 \checkmark Once deemed safe to join your child will be escorted to class by one of our staff members.

 \checkmark The children will wash their hands and remove their shoes before entering the class.

(please send empty shoe box and indoor shoes that will remain in camp for the week)

Sick policy:

 \checkmark Please see our parent handbook for the Camp Gan Israel sick policy

 \checkmark We reserve the right to decide if your child is not healthy enough to be at camp.

 \checkmark Our sick policy is updated to reflect a 48 hour wait time after fever or illness is over, including the procuring of a Dr.'s note that no COVID-19 testing is necessary or that child is COVID-19 free.

 \checkmark Hard copy note or tele-doc note is acceptable.

 \checkmark We reserve the right to ask you to keep your child home if another child or family member in the house is sick.

5. DROP OFF AND PICK UP

 \checkmark You will receive a drop off and pickup time slot for your child.

✓ Drop off and pickup will take place in the circle each day.

 \checkmark We need you to stay within your allotted time slot for drop off and pickup.

 \checkmark If you arrive after your assigned drop off or pick up time, you will have to wait until all other time slots have finished dropping off or picking up.

6. MODIFIED ENTRY AND ACCESS TO OUR CAMPUS

✓ All persons except the following will be prohibited from accessing our building: Operation staff, Law enforcement officers, Child Care Licensing staff, and Department of Children and Families protective services staff; professionals providing services to children; children enrolled at the operation; Chabad of Boca Raton staff; Torah Tots Academy staff ✓ Parents will not be allowed in the building.

 \checkmark All permitted staff will be rescreened daily before entering the building.

7. STAFF SCREENING PROCEDURES UPON ARRIVAL

 \checkmark In addition to the previous screening of our staff's health and safety, they will be rescreened daily upon arrival.

8. MAINTAINING AN ADEQUATE RATIO OF STAFF TO CHILDREN TO ENSURE SAFETY.

 \checkmark Our class sizes will be adjusted to accommodate for the recommendation of smaller groups in a classroom.

✓ Children and childcare providers will not change from one group to another.

 \checkmark Each class will remain in their respective classrooms and not change classes during the day.

 \checkmark Outside play will be limited to only one class at a time.

 \checkmark We are not mandating masks for the staff.

 \checkmark We are not permitting masks for the children.

 \checkmark Teachers will wear a mask when feasible during snack, lunch, and bathroom/changing time.

9. FOOD

- \checkmark We will not be serving family style meals or snacks.
- \checkmark All food must be brought from home.

 \checkmark You will need to send a morning snack of fruit or vegetable, healthy afternoon snack, and full lunch, as well as a labeled water bottle that we will refill throughout the day.

- \checkmark You must include all the utensils, plates, forks, knives, spoons etc. for your child.
- \checkmark Everything will be returned daily.

If you are uncomfortable with sending your child to school with these precautions in place, please keep your child at home. These precautions are in place to provide every effort to keep every child and family safe; however, this does not provide any guarantee of any kind. As the parent of the child attending, you assume all risks associated with allowing your child to begin attending. We are doing everything we can in our power to keep every child safe during this time. Working together during this time is important.
